60 DAYS PERMIT ADDENDUM

The Permittee, whose signature appears below, is authorized to drive on public highways of the CNMI for the purpose of learning how to operate a motor vehicle. The Permittee is NOT authorized to drive alone at anytime! The Permittee must be accompanied by an individual who is at least 21 years of age, a holder of a valid CNMI 3 year Driver's License with at least one year experience operating a motor vehicle, and to follow ALL laws, and regulations that pertain to the operation of a motor vehicle in the CNMI. Failure to comply with the above regulation is cause for revocation of your Permit by the Bureau of Motor Vehicle for a period not to exceed 6 months. The Bureau then before reissuing the revoked permit will require the individual to undergo all required examination for a permit all over again.
